Rate Revision for Medicare Supplement Closed Series Business

Rate increases are occurring for the current B 21492 Preferred & Standard Medicare Supplement policies. These new rates are effective 07-01-2019. Existing policyholders will be notified of this premium change within the state mandated timeframe. The chart below lists the plans and their percentage of change.

Additionally, the Household Discount is being increased from 7% to 9% for qualified applicants effective 07-01-2019.
