2021 Copay and Deductibles Available

The Center for Medicare and Medicaid Services (CMS) has announced the **2021 Medicare Premiums and Copay/Deductibles**.

Medicare Part B Premium

The Medicare Part B standard monthly premium will be **\$148.50** in 2021, compared to \$144.60 in 2020.

Note: The income-related Part B premiums for 2021 will vary depending on the extent to which an individual beneficiary's income exceeds \$88,000 (or a married couple's income exceeds \$176,000).

High Deductible Plans F and G 2021 Deductible

The 2021 annual deductible amount for the High Deductible Plans F and G is \$2,370 compared to 2020 annual deductible of \$2,340. The deductible amount for the high deductible version of plans F and G

represents the annual out-of-pocket expenses (excluding premiums) that a beneficiary must pay before the policy begins paying benefits.
