WHAT'S NEW?

RATING AREAS and AGE-BASED RATING

Beginning January 1, 2023, **area rating** is being introduced for new and current insured members*, while **age-based rating** is being introduced for new plan effective dates of January 1, 2023 and later.

With **area rating**, all insureds in the same rate class, in the same area, pay the same rate (excludes discounts and surcharges). This means rates within a state will vary by geographic region, identified by zip code. Oregon will have two rating areas, allowing for more targeted rates. With **age-based rating**, initial rates are determined by a member's age at their plan effective date and can increase as they age. Any change in premium will impact all members of the same age and go into effect on the policy anniversary date.

*Members who have an AARP Medicare Supplement or AARP Medicare Select Plan with a plan effective date prior to June 1, 2010, are not impacted by the new area rating.

Reminders

- AARP Medicare Supplement Insurance Plans' monthly premium generally changes once a year unless discounts change or wear off.

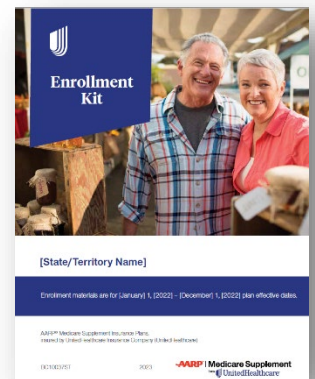

The new Enrollment Kit includes the new 2023 rates through December 1, 2023 plan effective dates and any changes that are being implemented in Oregon.

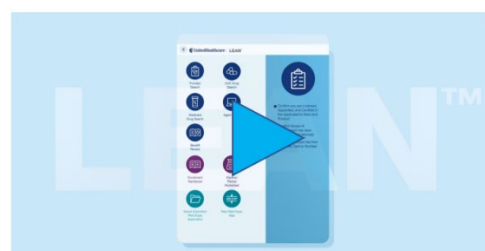
