



## New Rates for Plan F Business

Effective **September 1, 2020** there will be new reduced rates on United World Michigan and North Carolina Plan F for:

- New business; and
- Affiliate conversions only

Please note: An individual currently in a United World Plan F prior to 9/1/20 cannot underwrite into that same plan.

Due to MACRA legislation, Medicare supplement Plan F may only be issued to individuals who were Medicare eligible prior to January 1, 2020. Expectations are that this change in regulation will shift enrollment from primarily Open Enrollment (prior to MACRA legislation) to primarily Underwritten (under MACRA legislation). Due to this expected increase in underwritten business, a premium discount factor on Plan F premium rates was filed and approved in Michigan and North Carolina. This discount factor allows us to lower premium rates and help sustain our Plan F block of business.

The following rate adjustments will be effective 9/1/20.

*\*In Michigan, the 27.5% rate reduction on Plan F is based on the Plan F rate after the 8/1 12% adjustment. In North Carolina, the 26.5% reduction on Plan F is based on the Plan F rate after the 9/1 12% adjustment.*
