Conversions

All Medicare supplement policies are issued according to the underwriting company noted on the Medicare supplement application. Should your client wish to convert to another policy (from GPM Life to GPM Health & Life), you must complete and submit all applicable conversion paperwork, including your client's signed authorization. Be aware that conversions are subject to underwriting.

Agent of Record: According to agent of record rules, commissions for GPM Life or its affiliate Medicare supplement replacements will be paid only when the original writing producer sells the replacement policy.

Release Kits

Product release kits for your resident state will mail shortly. Kits include the state specific application book, product brochure, if approved, underwriting guide and contact card.
